(Real Property Transfer Tax)

Any document that transfers an interest in real property is subject to transfer tax and needs a completed Declaration of Value form. The Transfer Tax fee due is based on **\$1.95 per \$500 valuation** less assumed encumbrances. If there is no tax, the exemption number and an explanation must be indicated on the form.
